### **Special and / or sensitive personal data that we process**

### **For what purpose and on what basis do we process personal data**

Keydollar BV processes your personal data for the following purposes::

### **Automated decision-making**

Keydollar BV does not make decisions based on the automated processing of matters that can have (significant) consequences. Meaning that these decisions that are taking by a computer programs or –systems, without a person (for example an employee of Keydollar) sitting between them. them.

### **Cookies, or similar techniques, that we use**

Keydollar BV uses function analytical and tracking Cookies. A Cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. Keydollar BV uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your

preferred settings are remembered. These Cookies are also used to make the website work well and to optimize it. In addition, we place Cookies that keep track of your browsing habits so that we can offer customized content and advertisements.

You can opt out of Cookies by setting your internet browser so that it does not store Cookies anymore. In addition, you can also delete all information previously saved via the setting of your browser.
